Further, the candidates are required to appear in the driving test and personal interview to be held on **9th & 10th September, 2016** at **10:00 A.M.** in the office of **Advocate General, Udyog Bhawan Building, Shimla-1** and no call letter shall be issued for driving test and personal interview. 2. Applications received after due date or incomplete application or not in accordance with the prescribed format, shall be out-rightly rejected and no correspondence will be entertained in that respect.
3. The words "Application for the post of Driver" should be super scribed on the top of the envelop containing application form.
4. The candidates are required to submit attested photo copies of all relevant testimonials so as to show their qualification.
5. No person shall be eligible for engagement on daily wage basis if he is below 18 years of age as on the day of January of the Recruitment Year i.e. 2016 and not more than 45 year of age on that date. However, in the case of the candidate belonging to Scheduled Caste, Scheduled Tribe, Other Backward Classes or who is an ex-serviceman upper age limit shall be the same as may from time to time, be prescribed by the State Government for engagement of daily wages.
6. The selected candidates shall be offered appointment on the daily wage basis.
7. No TA/DA shall be admissible to the candidates called for the interview.
