**OFFICE ORDER**

1. This post will be purely daily wage basis.
2. He will be paid @ Rs.200/-per day (Rupees two hundred) only as per Government of Himachal Pradesh, Finance department letter No. FIN-(PR)B(7)-33/2010, dated 12-04-2016.
3. The offer/engagement is liable to be withdrawn at any time in case his performance/conduct is not found satisfactory.
4. They will have to submit a Bonafide certificate issued by competent authority.
5. They shall be allowed a day of rest every week which shall be Sunday and in addition they shall also be entitled 3 paid National Holidays i.e. 26<sup>th</sup> January, 15<sup>th</sup> August & 2<sup>nd</sup> October.
6. Their appointment will be subject to the production of the following documents:-
  - (i) They shall have to submit original academic certificate and proof of their age to the officer concerned before joining the post along with attested copies thereof.
  - (ii) They shall have to submit a certificate of their fitness from a Government/ Registered Medical Practitioner at the time of joining duties in this department.
  - (iii) Character Certificate issued by the competent authority.
7. No traveling allowance will be paid to them for joining the post.
8. If any information or declaration furnished by you proves to be false or any material information is found to have willfully suppressed, you shall be liable for removal from service and such other action as the Department may deem necessary.
9. In case you are prepared to accept the offer of appointment on the terms and conditions mentioned above, you may please report yourself for duty along with above relevant documents in the office of the Advocate General, H.P. not later than 15 days.
