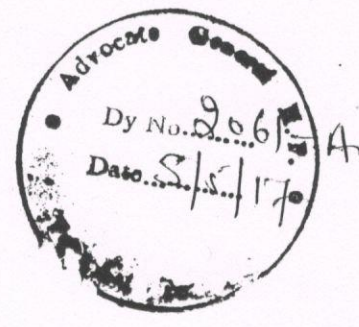

**OFFICE ORDER**

Pursuant to the Government of Himachal Pradesh, Department of Personnel letter No. PER (AP) C-B (2)-2/2015-L, dated 4<sup>th</sup> May, 2017 and on the recommendations of Departmental Screening Committee constituted vide this office order No.1-32/2006-27727-32 dated 1<sup>st</sup> October, 2016, the services of Shri Surender Kumar, Restorer appointed on contract basis vide this office order No. 1-16/2003-II-35401-6, dated 19<sup>th</sup> October, 2011, on completion of three years of services as on 31.03.2017 is hereby regularized in the pay scale of Rs. 5910-20200+2400 Grade Pay with immediate effect on the following terms and conditions:-

1. The appointments are purely temporary but likely to continue.
2. He shall be on probation for a period of two years in the first instance and during the period of probation, his services can be terminated at any time without giving any notice.
3. He will produce certificates of educational qualification and Bonafide Himachali Certificate from the Magistrate, Ist Class if not produced earlier.
4. He will produce the certificates of age if not produced earlier.
5. He will be the member of Group Insurance Scheme as introduced by the Government of Himachal Pradesh.
6. He will produce medical fitness certificate from the Chief Medical Officer.
7. He will produce the certificate of Schedule Caste/Schedule Tribe/Ex-serviceman as the case may be, from the Magistrate Ist Class concerned.
8. The regularization shall be subject to the verification of character antecedents as provided in the Himachal Pradesh Financial Rules.
9. The contractual appointee who are regularized shall be liable to be posted anywhere within the State.
10. He will take the oath of allegiance/faithfulness to the Constitution of India.
11. He will submit a declaration to the effect that they shall have not more than one living wife/husband.

If the regularization on the above terms and conditions is acceptable to him, he should report for duty to the undersigned within seven days positively, failing which his regularization will be treated as cancelled.
