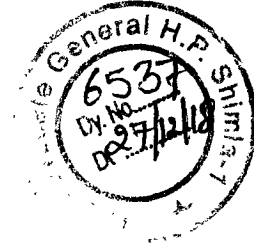

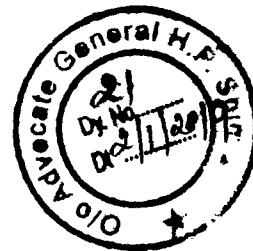

The Governor Himachal Pradesh is pleased to appoint the following Assistant Advocate General on tenure basis in the office of Advocate General Himachal Pradesh with immediate effect:-

The terms and condition of their appointment are as under:-

1. They will be whole time Government Servant and will not accept any case against the State Government.
2. Their services will be purely on tenure basis and can be terminated at any time without any notice and without assigning any reasons.
3. They will do all criminal, quasi criminal court cases entrusted to them by the Advocate General, Himachal Pradesh Government and Legal Remembrance and no payment will be given for this purpose.
4. In the matter of leave and travelling allowance, they will be governed by the Rules applicable to the State Government employees.
5. Their services will be purely on tenure basis and as such, they will not be entitled to any other service benefits viz pension, gratuity and encashment of leave etc.
6. The terms & conditions of their fee structure etc. will be issued separately.
