Notification

In pursuance to the provision of Rule 12 of "The Engagement of Law Officer for Supreme Court of India and High Court of Himachal Pradesh Rules, 2018" the Governor, Himachal Pradesh is pleased to appoint Sh. Sumesh Raj as Additional Advocate General in the office of Advocate General, Himachal Pradesh with immediate effect subject to the following terms and conditions:-

1. He will defend the cases of class of cases, which are specially assigned/ entrusted to him by the State Government or by the Advocate General Himachal Pradesh.
2. He will not accept any case against the State Government and or its officers/officials and its instrumentalities, which have been specially entrusted to him by the State Government or by the Advocate General, Himachal Pradesh.
3. His services being purely temporary based can be terminated at any time without any notice and without assigning any reason and as such he will not be entitled to any other service benefits viz. pension, gratuity and encashment of leave etc.
4. In the matter of leave and travelling allowance, he will be governed by the Rules as applicable to the State Government employees.

The above terms and conditions can be further revised and amended as per requirement from time to time. He will be entitled for retainer ship as notified vide this Department's Notification No. Home-B(B) 7-1/2018 dated 29th January, 2019.
