- (v) The rules, regulations, instructions, manuals and records held by it or under its control.
- (vi) A statement of the categories of documents that are held by it or under its control.
- (vii) The particulars of any arrangement that exists for consultation with or representation by the members of the public in relation to the formulation of its policy or administration thereof.
- (viii) A statement of the board, counsels, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public.
- (ix) A directory of its officers and employees.
- (x) The monthly remuneration received by each of its officers and employees including the system of compensation as provided in its regulations.
- (xi) The budget allocated to each of its agency, indicating the particulars of all plans proposed expenditure and reports on disbursements made.
- (xii) The manner of execution of subsidy programmers including the amount allocated and the details of beneficiaries of such programmes.

- (xiii) Particulars of recipients of concessions, permits or authorization granted by it.
- (xiv) Details in respect of the information available to or held by it, reduced in an electronic form.
- (xv) The particulars of facilities available to citizen for obtaining information, including the working of a library or reading room, if maintained, for public use.
- (xvi) The manes, designation and other particulars of the Public Information Officers.
- (xvii) Such other information as may be prescribed and thereafter update these publications every year.
